Large, consolidated documents, such as litigation referrals and batches of medical reports, were particularly painful. Staff could spend a whole day on a single file, splitting up the various documents and then manually naming each one. Compliance with the firm's naming convention waned as document volumes surged and the staff moved faster to keep up. These trade-offs often cost attorneys' valuable time. Jeffrey Ward, Founding Partner, noted, "There were several times that I remember spending hours searching for a discovery response or other important documents that I knew were in the file but couldn't locate, even with Litify's advanced search."

The Solution

MDSW sought a scalable solution that integrated with Litify, was proven to understand the personal injury and work comp documents it received, and that could quickly, accurately, and consistently get all its incoming mail and email attachments named and saved into its digital practice management system and routed to the people that needed to see them. It found this solution in Foundation Al.

Knight remarked, "The implementation process was incredibly smooth, and the system is so easy to use." The FAI Platform automatically ingests scanned mail, email attachments, and even e-faxes and then uses AI to match each document to the correct matter, name it to MDSW's desired naming convention, save it to the correct subfolder, and alert relevant personnel according to MSDW's specific rules.

For larger, consolidated files, FAI employs a proprietary unitization model to split out individual documents. The platform can either name and export each document into separate folders within Litify or create chronologically ordered batches for efficient review.

Law firm staff can easily validate FAI decisions through an intuitive user interface before finalizing document uploads. Knight explains, "I simply confirm that the information has been extracted correctly and make any necessary adjustments. From there, it automatically sends the document to the right folder in Litify and emails the attorney and paralegal with a direct link to the document."
